### Requirements:

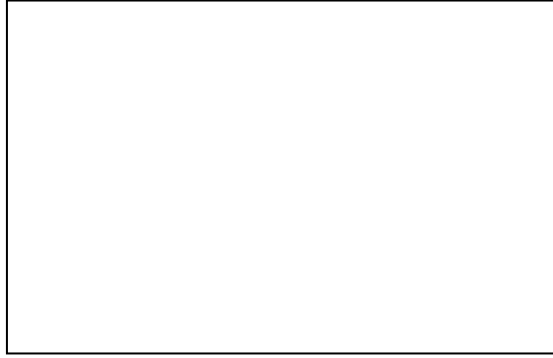
- A) Please read, sign, and return this contract as soon as possible
- B) If you choose, make a copy for yourself
- C) Contract must be received no later than 2 weeks before your event
- D) We will not reserve a trailer for your specified date until the electric and water connections are confirmed, and the receptacle drawing is signed and returned
- E) We cannot guarantee that we will fulfill our obligations if the following is not met:
  - 1. 220 electric with 30 amp service
  - 2. Potable water connection for a hose
  - 3. Restroom facilities available
  - 4. 600 pre-orders for sticky buns for each day that the trailer is reserved
    - If you do not meet the preceding requirements, you still may do a fundraiser, however you will have to pick up your buns at the Williamsport, Lancaster, or Exton location.
    - You must pre-arrange which location will satisfy your order

If the above conditions are met we can guarantee up to 1200 sticky buns priced at \$\_\_\_\_\_ each (Both parties to initial \_\_\_\_ \_\_\_\_) in a given day, unless we experience equipment malfunctions. If a malfunction occurs, that limits us from fulfilling your order, we will provide you with enough sticky buns to fill your pre-orders as soon as possible. The action taken may require us to deliver the sticky buns to you or have another sticky bun trailer at your event, both of which are not guaranteed for the original date. We will not be held financially responsible to your organization for lost sales in the event of equipment failure.
